LEGISLATION REVIEW

Monday at 11:59 PM was the California Legislature's deadline to vote on pending bills. Over the past couple of months, we've been working tirelessly alongside our fellow police organizations to help amend, or in some cases stop, a long list of bills aimed at significant police reform in the state.

The most concerning bill was SB731, which tried to establish a process to decertify police officers who have committed certain offenses. Once decertified, a police officer would no longer have a "license" to work in the state. We aren't against a fair process for decertification, but this bill was not fair. The bill was too wide-ranging, offered no due process or appeals, and could have led to officers being decertified for even minor infractions.

A lot of work went into making sure lawmakers in the state heard the voices of our police officers on this issue. Thankfully, that work paid off.

SB731 never came up for a vote Monday and is not moving toward becoming a law. The FOP, alongside our partners in law enforcement, are committed to working with lawmakers and stakeholders next year to look for a fair process for decertification.

Other police bills that were considered last night:

SB776 – this bill sought to expand the records disclosure process for uses of force and similar cases under 1421. 776 did not make it to a final vote and will not move on to become a law.

AB66 – this would have barred law enforcement from using rubber bullets, tear gas or similar crowd control devices. This bill also failed to come up for a vote and will not move on.

AB1196 – this is the bill that bans the use of the carotid restraint or choke hold. This bill passed on the floor and will be sent to Governor Newsom to sign into law.

AB1506 – this bill establishes a special prosecutor within the state DOJ to handle officer involved shootings and uses of lethal force when requested by a local agency or district attorney. This bill will also be sent to the Governor to sign into law.


